Dave made a motion to approve, Glen 2nd, motion carried to approve as read

ATV/UTV Updates: Evan Mercer stated that all roads on the Durand side of the river are open. The
Amendment for the elimination of the Sunset Clause for the Town of Waubeek was discussed, noting
that this issue should be reviewed every year to re-evaluate. Glen made a motion to approve, Brice 2nd,
all in favor, motion carried

A resident in attendance stated she has witnessed many ATV/UTV vehicles going very fast down her
road, she therefore did not feel it should have been included in "The All Roads Open Clause" - she was
advised to report these situations to the club, Evan stated they want to be proactive to eliminate such
issues

Citizen Concerns: many concerns were voiced by town residents who live in the immediate proximity of
the acerage purchased by the Durand-Arkansaw School District. Copies of the Town R1 Residential
Zoning were passed out which notes the uses permitted does include churches & schools. Dave stated
that all the town has control over is access off our town roads, other than that the issues at hand need
to be directed to the School Superintendent. It was requested that the Town have its Ordinance
reviewed by a lawyer or hire an administrator, Dave said he would speak with lawyers and a letter
would be mailed out advising of what he finds out.

Consideration of the applications for Operator's Licenses were reviewed and based upon background
checks conducted Dave a made motion to approve Andrew Anderson & Cheryl Patraw. Glen 2nd, all in
favor, motion carried

Dave made a motion to deny the application of Mark Hillestead based upon the background check
conducted, Glen 2nd, all in favor, motion carried
